## **CONCEPT NOTE & AGENDA**

### Goal of the meeting

The Consultation Meeting on Large Marine Ecosystems (LMEs) and Coastal Partners plays a crucial role in fostering the development of collaborative efforts and partnerships within the framework of LMEs. By actively engaging leaders in marine science, coastal management, biodiversity conservation, and projects focused on coastal climate change adaptation, this gathering serves as a dynamic platform for knowledge exchange and strategic discussions. It provides a global forum for Global Environment Facility (GEF)-funded and other marine and coastal practitioners, partner organizations and institutions, including Regional Seas organisations and Fisheries Management Organizations, international NGOs and regional community leaders. The primary goal is to exchange experiences and insights related to ecosystem-based management (EBM) of LMEs and effective ocean governance.

### **Overarching objectives**

- To continue strengthening the LME process and partnerships;
- To promote collaboration among LMEs, Regional Seas Programmes (RSPs) and Regional Fisheries Management Organizations (RFMOs), Areas Beyond National Jurisdiction (ABNJ) and River Basin Organizations (RBOs) in pursuance of the Sustainable Development Goals (SDGs), in particular the SDG14;

- To foster a mutually supportive global network of leaders and institutions engaged in marine and coastal ecosystem-based management, including LMEs, integrated coastal management (ICM), marine protected areas (MPA), marine spatial planning (MSP), sustainable blue economy (SBE), sustainable ocean planning (SOP) programme, Source-to-Sea management (S2S) and others, for discussing experiences and lessons learned;
- To mobilize knowledge resources, new scientific applications and tools to support the implementation of LME and marine projects, and organizational action related to priority knowledge topics;
- To mobilize partners to enhance the LME community's efforts towards the implementation of Strategic Action Plans (SAPs), as well as the implementation of Agenda 2030.

### Specific objectives of the LME23 Meeting

- To review progress in regions through GEF-funded marine and coastal projects, disseminating best practices, and discussing emerging issues requiring common responses;
- To consult the LME community on the progress of the work on updating the LME concept and strategy;
- To share the latest science, innovation, and knowledge from the ocean science community;
- To further elaborate on integrated approaches in the management of LMEs, such as the SOP Programme, S2S collaboration and inform on the status of GEF-8 Integrated Programmes (IPs);
- To discuss ways to sustain the results and impacts of the LME projects;
- To consolidate inputs to the Tenth International Waters Conference (IWC10) on sessions related to marine and coastal issues, other key events and processes, e.g. the United Nations Ocean Conference (UNOC 2025) process and help shape strategic priorities for the GEF-9 replenishment cycle;
- To inform on the status of the Data and Information Management (DIM) workstream and brainstorm on the next steps.

### **Expected Outputs**

- Input to the IWC10, UNOC 2025 & GEF9
- Roadmap for updating the LME concept
- Definition of outreach activities for the coming year
- Constitute a working group/s on DIM

### Proposed set-up

The meeting will take place at the UNESCO Headquarters in Paris starting on Monday 3 June in the afternoon until Wednesday 5 June. The proposed set-up will include presentations, facilitated panel discussions, interactive sessions and break-out working groups. The break-out groups will build on the presentations and discussions of the preceding sessions. The last session on Wednesday 5 June afternoon will be dedicated to a workshop on Data and Information Management (DIM). The LME23 meeting will gather ~ 70 participants representing the GEF implementing and executing agencies, regional organizations, NGOs, governmental representatives familiar with IW projects, partners from the private sector, other partners and practitioners from LMEs and adjacent river basins. Participants to the DIM workshop will include LME project managers and relevant DIM partners.
